## Anti Ragging Policy

Anti-ragging policy as per "The judgment of the Honorable Supreme Court of India dated 08/05/2009" in civil appeal number 887/ 2009 - UGC has notified "Regulations on curbing the menace of ragging in higher educational institutions"

As per the directives of Maharashtra prohibition of ragging act 1999...

### **Introduction:**

\*Ragging is a punishable offense and strictly prohibited in or outside of the college campus. \*Students are made aware of rules regulations and the guidelines of anti-ragging policy, strict adherence to student code of conduct.

\*This is enforced through frequent corner meetings , briefings in the student induction program , posters and notices displayed on notice boards as well as during admission process.

\*The anti-ragging cell has been constituted and students are familiarized with their names, phone numbers, college phone numbers.

\*A dedicated email ID- [antiragging.mca@gmail.com](mailto:antiragging.mca@gmail.com) has been created for mailing anti ragging complaints if any.

### **Objectives of the anti-ragging committee**

Anti-ragging committee will monitor and follow the state govt as well as UGC guidelines to ensure ragging free campus.

1. To make the students aware about the dehumanizing, traumatic effects of ragging .

2.To make the students aware of anti-ragging helplines and college mail ID for lodging ragging complaints or incidences that have been brought to the notice of the committee.

3.Strict adherence to the student code of conduct.

Filing a complaint:

Discriminatory harassment or any act of ragging, unwelcome verbal non verbal or physical conduct directed against any person or group based on color, religion, gender nationality, sex ,age, disability or that has been targeted to the incumbent students / fresher's with the aim of creating hostility in the work or academic environment that can affect the behavior or the performance of the students.

### **Complaints of discriminatory harassment or ragging:**

The matter should be promptly reported to the anti-ragging cell preferably immediately or up three months of the most recent harassment act.

A written complaint is to be handed over to the cell or dropped in the anti raging complaint box or mailed on anti [ragging.mca@gmail.com](mailto:ragging.mca@gmail.com)
